Minutes of the Regular Meeting of the
Board of Commissioners on May 10, 2010

Meeting called to order by Chair Rick Stone at 10:00 at the Administrative Office. Present were: Commissioners Durand, Norton and Stone, Chief Pollock and Administrative Assistant Rumelhart.

Approval of Agenda:

- **Commissioner Stone moved to approve the agenda as sent. Commissioner Durand seconded the motion. The motion passed 3-0.**

Approval of Minutes:

- **Commissioner Durand moved to approve the April 12, 2010 Regular Meeting minutes as sent. Commissioner Stone seconded the motion. The motion passed 2-0, with Commissioner Norton abstaining.**
- **Commissioner Norton moved to approve the April 26, 2010 Regular Meeting minutes as sent. Commissioner Durand seconded the motion. The motion passed 3-0.**

- EMS Funding – A discussion was held on the current balance of the Rescue Fund. It was decided to move \$10,000 of the Seattle City Light MOU funds from the General Fund to the Rescue Fund. **Commissioner Norton moved to approve Resolution 10-02, Operating Transfer of \$10,000 from the General Fund to the Rescue Fund. Commissioner Durand seconded the motion. The motion passed 3-0.** Additional discussions were held on EMS system funding and volunteers. No decisions were made.
